WHEREAS, Green County Code section 1-11-4 provides that the Finance and Accounting Committee of the Green County Board shall consider investment of funds not needed for current use by Green County and the County Treasurer in any manner permitted pursuant to Wisconsin State Statutes 66.0603(1m), where investments and deposits may be made to the reasonable advantage of Green County and its taxpayers; and

WHEREAS, pursuant to County code section 1-11-3:B(1), Green County has elected to participate in the State of Wisconsin's Local Government Pooled Investment Fund; and

WHEREAS, County Code section 1-6-10 authorizes the Treasurer to invest county funds, provided that he or she consult with the Finance and Accounting Committee on a regular basis regarding investment policy and procedure.

NOW, THEREFORE, BE IT RESOLVED by the Green County Board of Supervisors, in legal session assembled, that the Board approve the recommendation of the Finance and Accounting Committee authorizing the Treasurer to invest surplus county funds for the year 2009 at the following depositories:

RESOLUTION 4-5-09

Resolution Opposing The Governor's Proposed Changes to Insurance Laws and 2009 Senate Bill 20

WHEREAS, Governor Jim Doyle's 2009 Executive Budget Bill (2009 Assembly Bill 75) contains several anti-tort reform proposals including, but not limited to:

- \$ Changing comparative negligence laws to force a defendant to pay one hundred percent of the damages when they have as little as one percent of liability;
- \$ Forcing individuals, companies and local governments to pay for higher levels of insurance by increasing mandatory minimum auto insurance liability insurance limits;
- \$ Changing the definition of an Aunderinsured motorist@ in a way that increases insurance claims;
- \$ Requiring insurance companies to cover Auninsured motorist@ insurance claims when no contact was made between the insured's car and another car, thereby increasing the risk of fraudulent claims;
- \$ Allowing Astacking@ of coverage for Aunderinsured motorists@ such that the coverage limits for an accident are not limited to the policy relating to the particular vehicle involved in the accident;
- \$ Forcing excess or umbrella insurers to offer to cover certain claims when the coverage was not requested by the insured; and

WHEREAS, the aforementioned anti-tort reform proposals would significantly increase the cost of providing insurance in Wisconsin; and

WHEREAS, Green County currently procures its liability insurance through Wisconsin County Mutual Insurance Corporation (WCMIC); and

WHEREAS, WCMIC is a county owned and operated mutual insurance company created for the purpose of providing long-term stability in insurance coverage and insurance costs for counties; and

WHEREAS, as a mutual insurance company, WCMIC's increased cost of providing insurance resulting from the anti-tort reform proposals would be borne by counties and their taxpayers directly in the form of increased insurance premiums; and

WHEREAS, 2009 Senate Bill 20 is currently pending before the Senate Labor, Election and Urban Affairs Committee; and

WHEREAS, Senate Bill 20 would have a dramatic financial impact on counties by changing employment discrimination laws as follows:

- \$ Allowing claimants to collect unlimited punitive damages against counties contrary to current state and federal law;
- \$ Forcing counties to pay a punitive 10% surcharge to the court system in addition to unlimited damages;
- \$ Forcing counties to litigate issues of compensatory and punitive damages years after the initial discrimination complaint was filed;
- \$ Creating an irrational and inefficient complaint process where both parties have an incentive to litigate claims to the fullest extent possible; and

WHEREAS, Green County faces significant budgetary challenges related to the provision of critical state and county services at a time when state and federal financial support for such services is decreasing and the burden placed on Green County taxpayers is growing; and

WHEREAS, adding news costs for counties and forcing counties to increase their tax levies during our current economic downturn would be devastating to property taxpayers who can ill afford increased taxes or increased insurance costs.

NOW, THEREFORE, BE IT RESOLVED by the Green County Board of Supervisors, in legal session assembled, that the Board approve the recommendation of the Finance and Accounting Committee opposing the Governor's proposed changes to insurance laws included in his 2009 Executive Budget and the proposed changes to employment discrimination laws in 2009 Senate Bill 20 and strongly encourages its senators and representatives in the Wisconsin State Legislature to reject the Governor's proposals and Senate Bill 20.

WHEREAS, at the request of the Zoning Administrator, the Green County Land Use and Zoning Committee has reviewed the Green County Floodplain Ordinance; and

WHEREAS, the Green County Land Use and Zoning Committee has determined that the Green County Code is in need of updating in order to comply with the State's updated regulations.

NOW, THEREFORE, BE IT ORDAINED by the Green County Board of Supervisors, in legal session assembled, that Title 4, Chapter 8 of the Green County Code be repealed and re-created as shown on the attachment to this Ordinance.

ORDINANCE 09-0403

Creation of Green County Aging and Disability Advisory Committee and Repeal of Long Term Support Planning Committee

WHEREAS, the Green County Human Services Board has the responsibility to develop and make available to the residents of Green County a comprehensive range of human services in an integrated and efficient manner; and

WHEREAS, upon the Green County Human Services Board's recommendation, Green County has entered into the Family Care Program sponsored by the State of Wisconsin; and

WHEREAS, as part of that Program, there no longer is a need for a Long Term Support Planning Committee; and

WHEREAS, there is a need to establish a new committee to work with and make recommendations to the Human Services Board regarding aging and disability matters.

NOW, THEREFORE, BE IT ORDAINED by the Green County Board of Supervisors, in legal session assembled, that Section 1-7-27, Long Term Support Planning Committee, is hereby repealed in its entirety.

BE IT FURTHER ORDAINED by the Green County Board of Supervisors, in legal session assembled, that Section 1-8-H, Green County Aging and Disability Advisory Committee is hereby created to read as follows:

CHAPTER 8H

GREEN COUNTY AGING AND DISABILITY ADVISORY COMMITTEE

SECTION:

- 1-8H-1: Purpose**
- 1-8H-2: Membership**
- 1-8H-3: Powers and Duties**
- 1-8H-4: Terms**
- 1-8H-5: Meetings**
- 1-8H-1: PURPOSE**

The Aging and Disability Advisory Committee is appointed to provide advice and guidance to the Green County Aging and Disability Resource Services Unit and the Green County Human Services Board in matters relating to those citizens of Green County 60 years or age and over and to those citizens of Green County between the ages of 18 and 59 who are disabled physically, developmentally and/or challenged by mental health or substance abuse disorders.

1-8H-2: MEMBERSHIP

The Green County Board Chair, subject to Board approval, shall appoint 13 members. At least 51% of the members shall be aged 60 years or over. Membership shall further include at least one member representing adults with physical disabilities; one member representing adults challenged by mental health and/or substance abuse disorders; one member representing adults with developmental disabilities or disabled youth transitioning into adult services; and one member representing service providers. Further, the Committee shall include one member representing the Green County Human Services Board and one additional County Board member.

The County Board shall solicit nominations for vacant positions through local newspapers, Aging and Disability Newsletters, and other media advertising means. After the initial appointment, the Aging and Disability Advisory Committee will periodically review nominations and recommend qualified individuals for membership to the County Board Chair.

1-8H-3: POWERS AND DUTIES

11. Advise the Aging and Disability Resource Services Unit on the development and implementation of the County Aging Plan and ADRC Service Plan.
12. Provide financial oversight for the Aging and Disability Resource Services Unit.
13. Ensure that the terms of the Aging and Disability Resource Services Unit/County/Area Agency on Aging contract are fulfilled.
14. Collect information on the needs of older adults and adults with disabilities and make recommendations to Aging and Disability Resource Center Services staff.
15. Monitor progress on implementation of the Aging and Disability Resource Center Services Plan, County Aging Plan and other pertinent agreements.
16. Educate older people and adults with disabilities on issues of importance to them.
17. Advocate for the rights of older people to the Area Agency on Aging, elected officials of the County, State and Federal governments and to older populations.
18. Advocate for the rights of adults with disabilities to the Aging and Disability Resource Services Unit legislators and elected officials of the County, State and Federal governments and to adult populations.
19. React to and comment on concerns transmitted from the Human Services Board and/or the Aging and Disability Resource Services Unit.
20. Assure input from consumers, service providers, and local constituents in the general policies, procedures, practices, and goals of the Aging and Disability Resource Services Unit.
21. Study specific problems facing elders and adults with disabilities and make recommendations to the County Board, the Human Services Board and the Aging and Disability Resource Services Unit.
22. Review and Advise the Human Services Board and the Aging and Disability Resource Services Unit on budgetary and programmatic issues.
23. Report to other organizations on information and issues relevant to senior citizens and adults with disabilities.
24. Serve on committees as needed.
25. Attend regular Advisory Committee meetings.

1-8H-4: TERMS

Appointed members shall be expected to serve three years. No member shall serve more than two consecutive three-year terms. County Board members appointed to the Committee who are not elected or who do not seek election at the end of their term, but who remain members of the Committee may remain members of the Committee until such time as their successor is appointed by the Green County Board Chair. Appointment of successors shall be done promptly upon notice of a vacancy by the Green County Board Chair.

1-8H-5: MEETINGS

The Aging and Disability Advisory Committee shall meet on a regular monthly basis unless the Committee determines some other schedule.
