## RESOLUTION 3-1-10

### Resolution Approving Health Insurance Contract (Over \$75,000)

**WHEREAS**, County Code Section 1-11-2, entitled COUNTY PURCHASES AND CONTRACTS, provides for review, approval and execution of all County contracts and purchases necessary to carry out approved budget operations; and

**WHEREAS**, Section 1-11-2(A)(4) STATES: Cost or price in excess of seventy-five thousand dollars (\$75,000.00), recommendation by the appropriate department head and the supervisory committee to the full County Board with approval by the full Board before the purchase is made. Execution of the contract documents shall be by the Green County Board Chair and the appropriate Committee Chairperson, after the document has been reviewed by the Green County Corporation Counsel.

**NOW, THEREFORE, BE IT RESOLVED**, by the Green County Board of Supervisors, in legal session assembled, that the Board approve the recommendation of the Green County Personnel and Labor Relations Committee for the contracting of services with the following agency for the contract year April 1, 2010 to March 31, 2011:

## RESOLUTION 3-2-10

### Resolution Increasing County Employee Health Insurance Monthly Premium

**WHEREAS**, Green County Code section 1-7-4 identifies the Personnel and Labor Relations Committee as the committee of record responsible for contracting, development, funding and determination of provider for county employee health insurance; and

**WHEREAS**, since April 1, 1991, Green County has operated on a self-funded basis with Auxiant serving as third party administrator; and

**WHEREAS**, monthly payments are submitted to Auxiant for claims and administrative expenses, with funds provided by premium rates established by the County Board, as recommended by the Personnel and Labor Relations Committee based on claims history and experience.

**NOW, THEREFORE, BE IT RESOLVED**, by the Green County Board of Supervisors, in legal session assembled, that the Board approve the recommendation of the Personnel and Labor Relations Committee for the changes in monthly health insurance rates as follows:
